2. Show hours: Friday & Saturday: 10:00am-5:00pm; Sunday: 10:00am- 4:00pm (vendors must be open all three days)
3. Teardown: Sunday after 4:15pm or at discretion of promoter. 4. No vehicles in show area during show hours. Vehicles allowed in show area on Sun. after 4:15p.m. 5. Vendor parking on property. 6. Professional Security provided Friday & Saturday nights. Promoter will be onsite for entire show. 7. DUSTAC COATING WILL BE PUT DOWN IN PARKING LOT. NO STAKING ALLOWED. USE WEIGHTS ONLY 8. No electricity available. Limited water available offsite. 9. In order to preserve the quality appearance of shows... All tents must be professionally made (EZUp or better quality) and must have WHITE tops. All tables must be covered or draped to the ground. All booth areas must be kept neat and clean. Stored items must be neatly put away, covered and not detract from the appearance of the show. No clearance or sale signs and no verbal pronouncements of ½ price or other sales promotions. 10. Vendors are expected to keep all products, display items and booth materials within the area assigned to them. This includes umbrellas, racks, chairs, tables, signs and anything else associated with the booth. 11. Limited Pets on approval. No children. 12. Shows are Smoke- Free: Smoking is not allowed in booths or in show area at any time including during show hours and during setup/ teardown. Smokers go outside show area to smoke. All shows are alcohol- free and drug- free, including during setup and teardown. Violations will result in loss of space, loss of all show fees and removal from show. 13. **The Town of Cave Creek requires all vendors have a Business License posted in their booth. Applications are available at our website or call 480-488-1400: vendors are responsible for obtaining their license and must show it at registration in order to setup.** Vendors are responsible for collection / payment of all applicable Sales Taxes. 14. New vendors (not shown with Dixie Green promotions): include three pictures of art / craft and 1 of booth. 15. No refunds on cancellations within 20 days of show date for any reason. 16.
