**1. Show Hours:** Saturday: 9am-5pm & Sunday: 9am-4pm. **SECURITY:** Sat. night. 6pm-8am

**2. Setup:** Sat. 5-9am. Bring dollies or carts.

**Teardown:** Sunday after 4:15pm (vehicle access may be delayed at discretion of promoter)

**3. EXHIBITOR PARKING:** across the street in the west parking lot next to City Bldg.

**4. Comm. / Mass Produced Guidelines:** NO commercial paintings, jewelry, photography, sculptures or metal art. Add \$50 to booth fee if you are exhibiting select commercial/ mass produced items. Contact us if you are unsure how you qualify.

**5. NO MATS REQUIRED** **6.** Weights required on all 4 tent legs. No staking of any kind allowed. **7.** Vendors are responsible for collection & payment of applicable sales taxes. Booth fee includes \$15 City of Flagstaff permit. **8.** \$25 late fee if not paid 30 days in advance. Mailed checks must be received 30 days before show to avoid late fees. **9.** No refunds on cancellations 30 days prior to show for any reason **10.** Checks that are postdated past deadline, have incorrect fee or no signature will be returned **11.** \$56 charge on NSF checks.

**12. NO OUT OF STATE CHECKS. LOCAL PHOENIX CHECKS ONLY. NO CHECKS AFTER 30 DAY DEADLINE:** cash or certified checks or money orders only... No Exceptions. **13.** In order to preserve the quality appearance of shows... All tents must be professionally made and must have white tops. All tables must be covered or draped to the ground. All booth areas must be kept neat and clean. Stored items must be neatly put away, covered and not detract from the appearance of the show. No clearance or sale signs. **14.** Vendors are expected to keep all products, display items and booth materials within the area assigned to them. This includes umbrellas, racks, chairs, tables, signs and anything else associated with the booth. **15.** Unacceptable behavior, not following the rules & misrepresentation of product may result in loss of space and all fees. Swearing, cursing & foul language will not be tolerated. **16.** No Children. Limited pets on approval. **17.** Shows are Smoke- Free: Smoking is not allowed in booths or on show property at any time including during show hours and during setup/ teardown. Smokers go outside show area to smoke. No exceptions. **18.** All shows are alcohol- free and drug- free, including during setup and teardown. Violations will result in loss of space and removal from show.

**19. INSURANCE:** All exhibitors must provide a one million dollar liability certificate naming Dixie Green Promotions as an additional insured (Fax: 602-375-0696).
