Checks that are postdated past deadline, have incorrect fee or no signature will be returned 5. \$25 charge on NSF checks 6. NO CHECKS AFTER DEADLINE: cash or certified checks or money orders only... No Exceptions 7. In order to preserve the quality appearance of shows... Tents required, white canopies preferred but not required, and all tables must be covered or draped to the ground. All booth areas must be kept neat and clean. Stored items must be neatly put away, covered and not detract from the appearance of the show. No clearance or sale signs. Items and signs not considered appropriate will be removed at the request of show management. No spraying of paint, lacquer, etc. in show area. 8. Vendors are expected to keep all products, display items and booth materials within the area assigned to them. This includes umbrellas, racks, chairs, tables, signs and anything else associated with the booth. Items outside the area will be moved at the request of show management. 9. Water and electricity are not available at any show. Bring dollies/ carts: vendors may have to cart in. Contact us if questions about a specific show. To protect your booth and those around you, weights are required. 10. No children. Pets on approval. 11.
